PROGRAM STAFF WORK WITH AREA YOUTH TO REDUCE UNDERAGE DRINKING

To the public, Chris Hass is a basketball

But to the students who participate in the SPRING Program's boys talking circle at Pellston High School in Pellston, MI, he is a fellow student, a friend and their peer mentor.

The boys and girls talking circles at Pellston High School are one of SPRING's outreach programs in which staff members work with Northern Michigan area youth in an effort to reach its goal of reducing underage drinking. Harbor Springs High School in Harbor Springs, MI, and Petoskey High School in Petoskey, MI, both look to do similar peer-to-peer mentoring.

The Associated Press named Hass, a 6foot-4 senior guard, the Class D Player of the Year and a member of its All-State team after Hass led Pellston to a 23-2 record in the 2011-2012 season and to its first state semifinal berth and first regional title since 1944. Hass, who will play basketball at Bucknell University, averaged 31 points a game for the 2011-2012 season.

"The boys look up to Chris as a role model, and they have a good relationship with him," SPRING Program Coordinator Angie Woodin said. "He helps them with their basketball techniques and teaches them about life. He's the



type of person they aspire to be. He and Miranda (Byard, the peer mentor for the girls talking circle) set good examples for the other kids."

Pellston Public Schools Athletic Director/Student Success Coordinator Cole Andrews started the boys talking circle on March 1, 2012 by introducing the topic of bullying, and Hass facilitated the talking circle.

"We didn't have anything like this when I was in school," Andrews said of the talking circle. "As a kid, you don't always want to talk to your parents about things, but you talk to your friends and peers about them.

"It's a good thing because the effects of bullying bothered me into my 20's."

Despite excelling in basketball, Hass said he is not immune to bullying.

'When you are successful at something, people try to find something wrong with you," he said. "No one is perfect. When people say things to me, I use it as motivation to prove them wrong.

"Just remember, you're not alone because bullying happens to everyone."

SPRING stands for Significant Prevention Resulting in New Generations and is funded by a federal grant which started in July 2009 and ends in July 2014. SPRING Program staff includes Director Dr. Cheryl Samuels, Coordinator Angie Woodin, Health Educator Arlene Naganashe, Outreach Workers Deleta Smith and Yvonne Goudreau and Clerical Assistant Ronda Ellis. The Community Organizer position is currently vacant, but it looks to be filled in the near future.

The SPRING Program is under the umbrella of the Substance Abuse/Mental Health Department, which is a part of the Health Department, and the SPRING Program is located at the LTBB Health Park in Petoskey, MI.

In addition to the talking circles, the SPRING Program has distributed "Parents Who Host Lose the Most" signs in the Petoskey, MI, Pellston, MI, and Harbor Springs, MI, areas for people to place outside their homes, schools and businesses; had people sign pledge cards to not serve minors and hung the pledge cards in the LTBB Youth Center in Petoskey, MI, the LTBB Governmental Center in Harbor Springs, MI, and the Petoskey, Pellston and Harbor

Police Officer SYMONS REMEMBERED AS INDIVIDUAL

Editor's note: The following article appeared in the *Petoskey* News-Review on March 28, 2012 and is reprinted here with permission.

Patrick Symons, an officer in two area police agencies who died Sunday (March 25, 2012), is remembered for his friendly and helpful demeanor. Symons, who was a full-time patrol officer with the Little

Traverse Bay Bands of Odawa Indians Police Department and worked part-time for the East Jordan Police Department, died as a result of a heart attack he suffered Sunday (March 25, 2012) while at home in East Jordan, MI, his wife Melissa said. He was

"Patrick truly was the meaning of a people person," said LTBB Chief Law Enforcement Officer Jeff Cobe.

Originally from West Branch, MI, Symons moved to East Jordan about 18 years ago. After a stint working in the foundry at East Jordan Iron Works, Melissa said her husband decided a

few years ago that he'd like to return to school and pursue his interest in becoming a police officer. He received his Associate degree in Law Enforcement from Northwestern Michigan College

in 2009, and began a part-time position with the East Jordan Police Department in 2009.

Symons took on a full-time job with the Odawa tribal police in 2010 while continuing to work part-time in East Jordan. "I think with Patrick being new to law enforcement, he had

a sense of maturity that's kind of hard to find in new recruits today," Cobe said. Cobe said this maturity perhaps stemmed from Symons' pre-

vious work experience in another field, and the time he spent helping raise a family. Symons showed an ability to be authoritative — as is often

required of police officers — and friendly at the same time, Cobe

Symons' wife noted his willingness to help when others needed it.

"If any friends called him or anyone called him, he would go help at a moment's notice," Melissa said.

Patrick Symons enjoyed riding his motorcycle, working on home improvement projects, playing with his children and watching them participate in sports, his wife noted, adding that he displayed a straightforward manner.

"He said it like it is," she said. "He wouldn't mince words. He would tell you what he thought."

Through the years, Symons had been involved in community activities such as coaching soccer, helping out with Little League baseball, serving on the East Jordan Fire Department and as a church youth leader.

After Symons suffered the heart attack, Melissa said she "Officer Symons" continued on page 21.







More Than \$599,000 in Fish and Wildlife Conservation Grants Awarded to Tribes in THE MIDWEST REGION

Editor's note: The following is a U.S. Fish and Wildlife Service Midwest Region press release dated March 19, 2012.

The Fish and Wildlife Service, Midwest Region is pleased to announce funding for three tribal

fish and wildlife conservation projects totaling \$599,978 through the service's fiscal year 2012 Tribal Wildlife Grant program. The following tribes received funding this year:



Tribal Wildlife Grants provide assistance to tribes for development and implementation of programs that benefit fish and wildlife resources and their habitat. Activities funded through the program may include planning for wildlife and habitat conservation, fish and wildlife conservation and management actions, fish and wildlife related research, habitat mapping, field surveys and population monitoring, habitat protection and public education relevant to the project.

Since 2003, 73 projects totaling more than \$11 million have been funded in the service's Midwest Region through the Tribal Wildlife Grant Program and the Tribal Landowner Incentive Program. These projects have made a big difference on the ground and have helped build capacity for tribal management of culturally important fish and wildlife species.

The following projects were funded this year: The Development of Ho-Chunk Nation Wildlife Management Plan and Native Species Restoration Plan - Ho-Chunk Nation (\$200,000). This project will establish a comprehensive wildlife management plan and native species restoration plan for Ho Chunk Nation lands. As part of its native species restoration efforts, the tribe will work with partners to pursue elk restoration in the Black River area of Wisconsin. Overall, the project will enhance the tribe's capacity to effectively manage its resources and contribute to resource conservation at a landscape scale.

Common Carp Research/Mitigation and Wild Rice Restoration on the Clam River System and Clam Lake— St. Croix Chippewa Indians of Wisconsin (\$200,000). This project will research the impacts of common carp, a non-native species, on wild rice and the ecological functioning of the Clam Lake System in Wisconsin. The project will also restore nearly 300 acres of wild rice. Working closely with other partners, the tribe's efforts will benefit waterfowl populations, the lake's fishery flickr.com/photos/usfwsmidwest. and culturally important wild rice beds as well as

Development of the Michigan Walleye Population Model for the 1836 Ceded Territory- Little Traverse Bay Bands of Odawa Indians of Michigan (\$199,978). This ongoing project will gather infor-

> mation to calculate population estimates of adult walleye and classify walleye lakes based on recruitment to further develop the walleye population model currently used in Michigan's inland lakes.

The refined model will be used to predict adult walleye abundance in order to effectively manage walleye resources in the 1836 Treaty Area of Michi-

The service received 119 proposals requesting over \$19.1 million in project funding this year. The proposals were reviewed by regional and national scoring panels and 23 projects totaling \$4,344,049 were funded. RECLUSIVE GRAY FOX SPOTTED IN NORTHERN MICHIGAN

LTBB Conservation Officer Mike McCreery saw this gray fox in Charlevoix, MI. The gray



fox, whose average weight is 10 to 11 pounds, lives throughout the United States from extreme southern Canada and into Mexico and Central America. They are not observed as frequently as red foxes due to their reclusive nature and more nocturnal habits. Gray foxes tend to be active from the late evening hours until dawn. They will readily climb trees, jumping from branch to branch while hunting or for protection. Their food includes rabbits, mice, voles, chipmunks, squirrels, fruits, insects, birds and eggs, carrion, corn, amphibians and reptiles. Their habitat is deciduous woodlands, thickets and swampy

INFECTED/DYING ASH REMOVAL OPPORTUNITY



The LTBB Natural Resource Department (NRD) has a limited amount of funds through the BIA Emerald Ash Borer Project that may be used to remove dead or dying ash trees or limbs infested with invasive Emerald Ash Borer (EAB) which directly threatens LTBB Tribal Citizens' property such as buildings, driveways and other similar structures or where falling trees or limbs could be hazardous to people. To be eligible, the property must be privately owned by tribal citizens and be located with the Reservation Boundary

in Emmet or Charlevoix counties. Property owners who wish to participate in this project should contact the LTBB NRD for an evaluation of infected or dying ash trees by an NRD staff member. If the site is eligible after the evaluation, NRD will make arrangements to have the trees removed. These funds are available on a first-come, first-serve basis until the funds are exhausted. NATURAL RESOURCE DEPARTMENT REMINDS PUBLIC TO LEAVE WILDLIFE IN THE WILD

Spring is the season for wildlife to give birth. The Natural Resource Department (NRD) reminds tribal citizens and other Michigan residents to resist the instinct to try to help baby animals who may appear to be abandoned because in nearly every case, a parent is nearby, and the baby animal is not abandoned.

Unseasonably warm weather may have Michigan's black bears and recently born cubs out roaming earlier than usual. Great-horned owl



chicks are already hatched and will be out of the nest before long.

"The truth is, the animal doesn't need help – for example, even if a fawn appears to be aban-

doned, its mother is almost always nearby," NRD Wildlife Biologist Archie Kiogima, Jr. said. "We appreciate the good intentions of those who want to help, but the animals are better off left alone than removed from the wild."

Kiogima, Jr. said it's not uncommon for does to leave their young unattended for up to eight hours at a time; an anti-predator strategy which minimizes scent left around the newborn animals.

"The same holds true for rabbits, ground-dwelling birds and other wildlife," he said. "Even avian parents will continue to care for hatchlings that have fallen from a nest."

NRD advises:

- Many baby animals will die if removed from their natural environment, and some have diseases or parasites which can be passed on to humans or pets.
- Some "rescued" animals which do survive become habituated to people and are unable to revert back to life in the wild. It is illegal to



possess a wild deer or any other wild animals in Michigan, and every day a deer spends with humans makes it that much less likely to be able to survive in the wild.

• Eventually, habituated animals pose additional problems as they mature and develop adult animal behaviors. Habituated deer, especially bucks, can become aggressive as they mature, and raccoons are well-known for this, too.

The LTBB Natural Resource Department is committed to the conservation, protection, management, wise use and enjoyment of the tribe's natural and cultural resources for current and future generations.







TAX AGREEMENT INFORMATION

The Department of Commerce (DOC) would like to remind the tribal membership about a few items pertaining to the Tax Agreement.

First of all, I cannot express enough how important it is to keep your address updated.

The first step in becoming a Resident Tribal Member (RTM) is to officially change your address with the Enrollment Department. This must be done in writing and as soon

The DOC cannot and will not change the estimated beginning date (EBD) (which is always the first in any given month) of a member's tax exempt status (see example below).

It is YOUR responsibility to update your address on file with the Enrollment Department. This date will affect how many months you will be able to file the Annual Resident Tribal Member Sales Tax Credit (Tribal Form 4013). It is to your benefit to be able to file for the maximum number of months for this credit.

In addition, being an RTM will allow you to purchase large items such as vehicles, boats, motorcycles and off the road vehicles tax exempt.

There is a form that needs to be filled out called a "Request for TCE" (Tribal Certificate of Exemption), which is available in my office. Once this form is completely filled out, I will then issue the RTM the actual Tribal Certificate of Exemption (Tribal Form 3998).

If you plan on purchasing any of these items, please contact me FIRST, and I will be happy to get you the form via e-mail or fax. I am also able to fax the TCEs to the dealership you are doing business with.

Being an RTM will also allow you to be tax exempt on utility bills such as phone, cable, gas, propane, electricity, satellite and cellular service. If you have not filled out a Utility Provider Survey, please contact the DOC, and I will be happy to get

Also, another important thing to remember is if you do move into the Tax Agreement Area (TAA), your RTM status does NOT take effect until the first day of the following month.

Example: I move to Petoskey, MI, (inside the TAA) on September 5, 2010. My RTM (EBD) status begins October 1, 2010. All updates are sent to the State of Michigan as close to the end of the month as pos-

The current limit on tobacco purchases is four cartons per week per tribal citizen age 18 and over. The same applies to all other tobacco products (OTP) packaged in similar fashion.

VANDERBILT, MI, CASINO HEAR-

ING

In March 2011, Federal Judge Paul L. Maloney ruled in favor of an injunction filed against the Bay Mills Indian Community on behalf of the State Attorney General's office and the Little Traverse

Bay Bands of Odawa Indians, who both asserted Bay Mills had illegally opened the Vanderbilt, MI, casino and was not operating on Indian land as claimed by Bay Mills leaders.

On April 2, 2012, Joy Yearout, Spokesperson for the Attorney General's office, said a May 31st court date had been scheduled last week for the case to be heard by the Michigan Court of Appeals, but because of a scheduling conflict, her office would be requesting a different date for the hearing.

She said the Attorney General's office planned on submitting a formal request to the Court of Appeals to reschedule the hearing on the merits of the case for a later date.

NEW CASINO BALLOT PROPOSAL PUT ON THE TABLE

A coalition of various developers, investors and Lansing, MI, types had their casino expansion ballot initiative language cleared for takeoff on April 3, 2012 by the Board of State Canvassers that

The establishment of eight new, privately run casinos would be backed into the State Constitution under the "Citizens For More Michigan Jobs" ballot proposal. It would wipe out the 2004 Constitutional amendment which requires any gaming expansion proposal to go through a local and state vote, but it would still require a local vote of the people before any new casino could get

The new casinos would be allowed on specific parcels in Detroit, MI, Lansing, MI, Romulus, MI, Grand Rapids, MI, Birch Run, MI, Clinton Township, MI, Cadillac, MI, and Pontiac, MI. The legal descriptions for all of the properties would be written into the State Constitution.

On the public front, the group includes former House Speaker Rick Johnson, former Lieutenant Governor John Cherry, former Department of Management and Budget Director Mitch Irwin and Pollster Steve Mitchell.

The released names of investors include Eldorado Golf Course owner Bob Meyer of the Cadillac/Clam Lake, MI, area; St. Clair Shores resident Brien Baker, lead developer of the Macomb County, MI, casino; Andrew McLemore, head of the Detroit Casino Partnership; Anthony Gray, who tried to get a Romulus, MI, casino through a competing ballot proposal last year and is now on board with this effort, and Andy Apostolopoulos of Pontiac, MI.





utility bills not allowed; cell phone, cable, satellite, Internet

4. Hand written receipts, cancelled

checks or money order receipts will NOT be accepted.





Springs schools; has roadside billboards near the Oleson's grocery store in Petoskey, MI, in Brutus, MI, and near the Pellston Regional Airport in Pellston, MI, which include "Text a Trooper" information where people can anonymously report underage drinking; and is in the process of developing an evidence-based, vertical tribal ID program which was detailed in last month's Odawa



SPRING Program dropped off "Parents Who Host Lose the Most" signs in mid-April 2012, prior to homecoming, prom and graduation parties, and will pick them up at the end of June 2012.

"We've had good community support in regards to people displaying the signs, and we've received good feedback from both schools and individuals," Woodin said.

If it is approved by the Executive, the evidence-based practice, vertical tribal ID program would involve LTBB issuing vertical tribal IDs to all tribal citizens 20 and

A vertical tribal ID would immediately alert a store clerk at LTBB-owned Biindigen Gas Station and Convenience Store in Petoskey, MI, an individual is not old enough to purchase alcohol or tobacco or alert a security guard at LTBBowned Odawa Casino in Petoskey, MI, an individual is not old enough to gamble there. It is illegal to sell alcohol to individuals under 21 and illegal in Michigan to sell tobacco to individuals under 18. The gambling age at Odawa Casino is 19.





Barrier Free Units Available Equal Housing Opportunity

Housing Department Programs

Services are available to citizens residing within the 27 county service area. An application packet must be completed and returned to the Housing Dept. for processing to determine qualification. To obtain an application, please contact the Housing Dept. at 231-242-1540.

Short Term Rental Assistance: This program offers up to \$1,500 for new tenants who need assistance with the first month's rent and/or security deposit. This can be used ONE TIME ONLY and the rent requested must be affordable and can NOT exceed 35% of the household gross monthly income. Please note the application packet must be received and approved in advance of your moving into the rental in order to qualify for this program.

Home Improvement Program: This program offers up to \$2,500 for non-cosmetic home repairs and may be utilized once every five years.

Down Payment Assistance: This program offers up to \$2,500 or 10% of your mortgage (whichever is less) and can be used to purchase or refinance a home. In order for you to receive any grant dollars, you must be able to match the grant amount with your own guaranteed funds.

Foreclosure Prevention Program: This program offers up to \$3,000 to assist in foreclosure prevention.

Well & Septic Assistance Program: Funded by the Indian Health Services located in Sault Ste. Marie, MI this program provides the resources and technical assistance associated with the installation of a new well and sanitation service or replacement of deficient existing well/septic.

Credit Counseling: We provide confidential advice and referrals to assist tribal citizens in regaining their financial stability and credibility.

Tribal Rental Housing Program: The LTBB Housing Department offers 29 rental units in the Northern Michigan area. These units are available to rent to Tribal Citizens and most rents are based on a family's monthly income. Any Tribal Citizen interested in renting a unit from the LTBB Housing Department should contact our offices for an application. Currently, there is a waiting list for available units.

Michigan Indian Land Claims Settlement CERTIFICATE REDEMPTION UPDATE

Submitted by the Trust Fund Board

It has been more than a decade since the original Michigan Indian Land Claims Settlement certificates were issued.

All adults have been paid or they have deferred payment to a later date, however, tribal children who were enrolled before December 16, 1997 but had not yet turned 18 are still in the process of redeeming their certificates.

The following steps are intended to aid in this process. Redeeming certificates from the Michigan Indian Land Claims Settlement Act, Public Law 105-143, are as follows:

- 1. Determine your eligibility: Tribal citizens who were enrolled, but had not reached the age of 18 on December 16, 1997 are eligible to redeem their certificates upon reaching the age of 18.
- 2. Sign your certificates with a notary: The tribal citizen redeeming his or her certificates must have a notarized signature.
- 3. Copy two pieces of identification: One piece of identification (e.g. Driver's license) must have a picture, and the second piece needs at least
- 4. Mail your signed certificates, the mailing address you would like your check sent to and two pieces of identification to the following address



Charity Events, Inc., an entity started by Reedy to develop and operate three venues in his entertainment district, signed an approved location agreement on March 29, 2012 with the MICHIGAN LOTTERY.

Keep a close eye on the candidates for President and Congress this year. Those who are elected could well decide the future of SOCIAL SECURITY AND MEDICARE. For the last year, Congress has been debating cuts to Social Security and Medicare as part of a deal to reduce the federal deficit. Over the last few years, various changes to Medicare and Social Security have been proposed. Some candidates have suggested substituting private retirement accounts for some or all of Social Security. Proposed changes to Medicare have included raising the eligibility age, reducing benefits, increasing copayments, establishing a voucher system or reducing payments to Medicare providers.

AFFORDABLE HEALTH CARE: WHAT'S AT STAKE, WHAT'S ALREADY IN **EFFECT AND WHAT IS STILL TO COME?**

Having failed to persuade Congress that requiring Americans to carry health care insurance is a bad idea, opponents of federal health care reform asked the U.S. Supreme Court to declare enforcing such a requirement would be illegal.

In three consecutive days of oral arguments which began on March 26th, 2012, lawyers representing Republican Attorney Generals from Michigan and 25 other states attempted to convince justices Congress exceeded its constitutional authority when it enacted the Affordable Care Act, whose sweeping provisions would extend medical coverage to 30 million unisured Americans and strengthen coverage for tens of millions more.

Opponents focused their attack on two elements of law - the so-called individual mandate, which requires virtually every non-poor citizen either to obtain coverage by 2014 or to pay the government a penalty tax, and new eligibility rules would add approximately 15 million people to Medicaid programs administered by the states.

LTBB Tribal Citizen Becomes Trine University's All-Time Winning Pitcher, Receives Accolades


LTBB Tribal Citizen Andi Gasco became Trine University's all-time winning pitcher when she captured her 41st career victory


The NHSC Scholarship Program removes the burden of overwhelming educational debt, allowing students to pursue their passion for primary care and serve the underserved.

For each year of financial support (up to four years), a scholarship recipient serves one year (minimum two years) in an NHSC-approved site in high-need urban, rural and frontier communities across the nation.

Scholarship support includes tax-free payment of tuition, required fees, other reasonable educational costs and a monthly living stipend (taxable).

All students applying to the program must be a U.S. citizen

or national and enrolled or accepted in an eligible degree program at a U.S. accredited school in Medicine: MD or DO; Dentistry: DMD or DDS; Nurse Practitioner (Adult, Family, Geriatrics, Pediatrics, Psychiatric Women's health); Certified Nurse Midwife; and Physician Assistant.



As in previous years, the National Health Service Corps Scholarship Program is expected to be competitive. If there are more qualified applicants than available funding, the NHSC will continue to prioritize applicants who are from a disadvantaged background and applicants who demonstrate a commitment to continuing to serve communities of need after their service to the NHSC is complete.


