- Luncheons for August cost \$4,194.00 for participants ranging from 59 – 82 people.
- Elders Department needs to find out about the Christmas Dinner as each elder can traditionally invite a guest, elders department may have to have two lists. According to the guidelines it will cover tribal elders, and with some elders inviting non-elder guests the cost will have to be divided, one for general fund and one for Title VI and split the cost. Maybe the casino has to send two separate invoices.
- In the past the cost of the Christmas Dinner has been over \$5,000.00.
- General Fund
 - The Elder Department will be able to send 12 elders to the next MIEA conference; the travel budget will be gone.
 - Food and Utility reimbursement requests are in greater amounts for utility. There is only \$4,620.00 left in that line item as of August 17, 2015.
- Falls Prevention
 - Outreach continues but still don't have the numbers projected in the grant.
 - We're planning on breaking the session into four 6 week sessions to see if we can't get more participants.
 - We will be offering classes at Native Way Gym, Community Center, Health Department and Government Center.
