They would really like to have a fire out there from time to time. Arlene Naganashe was wondering how much of a health hazard is it; to the environment, and the people also. Tammy, and Mike are really worried about their grandkids; they are hoping that none of them get hurt on any of the stuff in the fire pit.

Mike Smith was also letting the commission know that the toilet in the first bathroom for their home is running about every three to five minutes. Arlene Naganashe was saying that there should be some jobs that Richard Wemigwase can do, and others that need to be contracted out.

Mike Smith also, made a comment that Richard Wemigwase needs some help; even if it's part-time. Arlene Naganashe and Judy Pierzynowski suggested that we should draft a letter to John Givens with a carbon copy to the Tribal Chairmen, and the Tribal Administrator; about this very subject.

It's been brought to the attention of the Housing Commission that Richard Wemigwase seems to be on call 24/7, and that they don't pay for his fuel in the van that he drives, or even consider paying him mileage.
