Wah-Was-Noos-Da-Ke Playground Project

- WHEREAS** the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS** the Little Traverse Bay Bands of Odawa Indians (“LTBB” or “Tribe”) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS** the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected governing body of the Tribe;
- WHEREAS** the Tribe operates a Housing Department whose mission is to maintain healthy homes and a healthy environment, and seeking resources to build and rehabilitate affordable, high quality, safe and sanitary housing in Indian Country;
- WHEREAS** the Little Traverse Bay Bands of Odawa Indians Housing Department maintains an affordable housing complex that ;
- WHEREAS** the Kresge Foundation has announced the availability of funds for Healthy Environments with the purpose of improving the health and well being of vulnerable children from low-income families by making the places they live, learn and play safe and supportive of overall good health.

**THEREFORE BE IT RESOLVED** that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians supports this request for funding from the Kresge Foundation for a Little Traverse Bay Bands of Odawa Indians Wah-Was-Noos-Da-Ke Playground Project.

**BE IT FURTHER RESOLVED** that the LTBB Tribal Chairman, Vice Chairman, or Tribal Administrator, or another designee from the Tribal Chairman is authorized to execute any documents necessary to receive and administer funds under the grant.
