**Midwest Alliance of Sovereign Tribes Representative for  
Little Traverse Bay Bands of Odawa Indians**

**WHEREAS** the Waganakising Odawak, known as the Little Traverse Bay Bands of Odawa Indians, is a nation of citizens with inherent sovereignty and right to self-governance;

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians (LTBB or Tribe) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

**WHEREAS** the WOS 2012-001 authorizes a tribal membership to the Midwest Alliance of Sovereign Tribes, (MAST) and the representative shall be the Tribal Chair or Vice Chair or in the alternative a Tribal Council member if the Tribal Chair/ Vice Chair is unwilling or unable to participate

**WHEREAS** the Chairman has nominated himself, Tribal Chairman as the MAST representative or in the event that the Chairman cannot attend he nominates the Vice Chair, as alternate MAST representative

**THEREFORE BE IT RESOLVED** that the Tribal Council of Little Traverse Bay Bands of Odawa Indians approves the nomination of Fred Kiogima, Tribal Chairman as the LTBB representative for MAST until his term of Tribal Chairman has expired, or in his absence approves the nomination of Debbie DeLeon, Tribal Vice- Chair until her term of Tribal Vice – Chair has expired.
