

**WAGANAKISING ODAWAK STATUTE #2015-015**  
**AMENDMENT TO WAGANAKSING ODAWAK STATUTE 2015-009**  
**Gaming Enterprise Board**

**SECTION I. REPEAL and REPLACE**

**A. REPEAL:**

**SECTION VII. POWERS, DUTIES AND FUNCTION**

**A. POWERS**

2. Present an annual budget for the Gaming Enterprise Board to Tribal Council for approval that may include funding for such items as: meeting stipends; training or conference per diem, travel expenses and travel stipend; staff and consultants; office space and equipment, and other expenses necessary to carry out the duties and responsibilities of the Gaming Enterprise Board. The Gaming Enterprise shall reimburse the Tribal Government for any expenses incurred by the Board.

**B. REPLACE:**

**SECTION VII. POWERS, DUTIES AND FUNCTION**

**A. POWERS**

2. Present an annual budget for the Gaming Enterprise Board to the Tribal Council for approval that may include funding for such items as: meeting stipends; training or conference per diem, travel expenses and travel stipend; staff and consultants; office space and equipment, and other expenses necessary to carry out the duties and responsibilities of the Gaming Enterprise Board. The Gaming Enterprise shall administer the budget and expenses incurred by the Board. The Board shall not exceed

the budget approved by Tribal Council and a copy of the budget and expenditures shall be submitted to Tribal Council on a monthly basis.

**SECTION II. EFFECTIVE DATE**

Effective upon signature of the Executive or thirty (30) days from Tribal Council approval which ever comes first or if the Executive vetoes the legislation, then upon Tribal Council override of the veto.

**CERTIFICATION**
