RESOLUTION 03039601

Whereas To support the application to the Indian Health Services Tribal Management grants for funds for the 1996-1999 Little Traverse Bay Bands Health Structure Development Project; **and**

Whereas the Little Traverse Bay Bands of Odawa Indians wishes to provide for the perpetuation of our way of life and the welfare and prosperity of our people, to preserve the right of self-government, to protect our property and resources, **and**

Whereas the Little Traverse Bay Bands of Odawa Indians federal tribal status was reaffirmed with the signing of PL 103-324 on September 21, 1994, **and**

Whereas the next phase of our Tribal development is to identify the health needs of our Tribal members, and other American Indians, who live within the LTBB service area, **and**

Whereas the LTBB Tribal Council has determined that a sound management structure upon which future programs can be planned, and implemented funding generated based on substantiated need, **and**

Whereas the Little Traverse Bay Bands Health Structure Development Project is a project designed to meet the above-mentioned goals.

NOW THEREFORE BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council in open meeting on March 3, 1996 authorizes the Tribal Chairman, Frank Ettawageshik, to make such arrangements as are necessary to apply to the Indian Health Services for funding for the above named project.
