**WHEREAS :** the Little Traverse Bay Bands of Odawa Indians (L.T.B.B.) of Michigan is a federally recognized Tribe, as reaffirmed under P.L. 103-324, and enacted September 21, 1994, and

**WHEREAS :** the Little Traverse Bay Bands of Odawa Indians has law enforcement responsibility throughout the Tribe' reservation, and exercises usufructuary Treaty rights, and

**WHEREAS :** the Little Traverse Bay Bands Law Enforcement department has management and enforcement responsibility on the Tribe's reservation and throughout the territory ceded in the 1836 Treaty of Washington, 7 Stat. 491, which encompasses 23 counties in the upper and lower peninsula of Michigan, and

**WHEREAS :** the COPS (Community Oriented Police Services) grant would increase the Tribe's ability to provide effective and safe environment of it's Criminal Code throughout this vast area, and

**NOW THEREFORE BE IT RESOLVED,** that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians supports its Law Enforcement Department's proposal to the United States Department of Justice, Office of Community Oriented Policing Services, and

**BE IT FURTHER RESOLVED,** that Tribal Chairman Frank Ettawageshik is hereby authorized to execute all documents necessary to apply for, receive and monitor the grant.
