RESOLUTION

**WHEREAS :** the Little Traverse Bay Bands of Odawa Indians (L.T.B.B.) of Michigan is a federally recognized Tribe, as reaffirmed under P.L. 103-324, and enacted September 21, 1994, and

**WHEREAS :** the Tribe and its members are eligible for all services and benefits provided by the Federal Government to Indians, as reaffirmed by P.L. 103-324 because of their status as federally recognized Indians; and

**WHEREAS :** the interim Tribal Governing body of the Tribe is authorized by P.L. 103-324 to conduct business on behalf of the tribe's members until such time as a new constitution is duly adopted by the Tribe; and

**WHEREAS :** the Tribe is authorized to contract with the BIA under authority of P.L. 93-638, the Indian Self-determination Act, as amended to administer and implement such services; and

**NOW THEREFORE BE IT RESOLVED,** the Tribal Council of the Little Traverse Bay Bands of Odawa Indians hereby requests to Contract for Fiscal Year 2000 with the BIA under the authority of P.L. 93- 638, as amended for tribal programs including Education (J.O.M., Higher Education, AVT and Direct Employment), Enrollment, Social Services, Housing Improvement Program, Tribal Court, Natural Resources Commission and Law Enforcement, and authorizes the submittal of a contract to the Michigan Agency Office, Sault Ste Marie, Michigan; and

**BE IT FURTHER RESOLVED,** that the Tribal Chairman or his designee is authorized to negotiate and sign the contract and amendments and is also authorized to serve as the tribal senior official representative for purpose of the contract, and

**BE IT FURTHER RESOLVED,** that the proposed contract term be from the date of inception January 01, 2000 through December 31, 2000.
