HUD ICDBG PROPOSAL

WHEREAS The Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe as reaffirmed under Public Law 103-324 of September 21, 1994;

WHEREAS The Little Traverse Bay Bands of Odawa Indians has a significant need for the development of infrastructure in which to build housing for very low to low income families on the housing development site in Harbor Springs;

WHEREAS The Indian Community Development Block Grant program provides funding for the development of such infrastructure;

THEREFORE IT IS RESOLVED THAT The Little Traverse Bay Bands of Odawa Indians supports a grant proposal to the United States Department of Housing and Urban Development, Indian Community Development Block Grant program for the purpose of funding the construction of infrastructure for the development of very low to low income housing which will benefit the membership of the tribe.

FURTHER RESOLVED THAT The Little Traverse Bay Bands of Odawa Indians is leveraging \$1,163,000 of the Housing Departments NAHASDA monies for development of infrastructure and housing as well as an additional \$500,000 from the Tribe, to support the development of infrastructure on the Harbor Springs housing site.

FURTHER RESOLVED THAT Tribal Chairman Gerald V. Chingwa, or his successor Chairman, is authorized to execute any documents necessary to apply for and receive funds under the grant.
