**TRIBAL RESOLUTION # 091910-01**

**Request for Trust Acquisition of Parcels in Bear Creek Township,  
Emmet County, MI**

**WHEREAS** the Secretary of the Interior is generally authorized to accept land into trust for the Little Traverse Bay Bands of Odawa Indians (“LTBB” or “Tribe”) under the Indian Reorganization Act, 25 U.S.C. § 465, and specifically mandated to accept transfer of lands in trust for LTBB within Emmet and Charlevoix Counties, Michigan under 25 U.S.C. § 1300k-4(a);

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians possesses clear title in fee by virtue of the deeds recorded at Liber 1093 Page 824; and Liber 1070 Page 566, with affidavit of correction filed at Liber 1124 page 806; Emmet County Register of Deeds to the parcels located in Bear Creek Emmet County described therein, which legal descriptions are subject to review and correction during the trust application process;

**WHEREAS** these parcels form an important corridor between the Health Park, Victories site and Odawa Casino Resort for purposes such as transportation and signage;

**THEREFORE BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians requests that the Secretary of the Interior accept the above described parcels in trust for the Little Traverse Bay Bands of Odawa Indians.

**CERTIFICATION**
