TRIBAL RESOLUTION # 121015-05

Use of 3rd Party Billing Funds, in the amount of \$7,438.00, for Dental Clinic Construction

WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;

WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

WHEREAS the Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the Tribe on February 1, 2005;

WHEREAS the Little Traverse Bay Bands of Odawa Indians, according to the Tribal Constitution, directive principles, is directed to "Promote with special care the health, ... of all people" and has established the improvement of public health as among the primary duties of the Government; and

WHEREAS supplemental funding is needed to support the operations and services provided by the LTBB Dental Clinic;

THEREFORE BE IT RESOLVED that Council approves the use of the 3rd party billing funds, in the amount of \$7,438.00, to be used in FY 2016 for ventilation construction at the Dental Clinic.
