

THIS COURT FINDS:

1. This Court entered a default judgment against the Respondent on January 27, 2004.
2. The Respondent was granted an extension of time to pay the default judgment against him on June 11, 2004.
3. Respondent did not pay the outstanding fine and court costs in this matter by July 12, 2004 as ordered by this Court on June 11, 2004.
4. A Show Cause Hearing was held on August 20, 2004. Respondent failed to show or contact the Court.

WHEREFORE, IT IS ORDERED THAT:

1. Respondent's LTBB Natural Resources privileges and licenses be revoked.
2. Respondent is not eligible for reinstatement of privileges or licenses until eligibility is established by this Court.
3. Respondent must petition the Court for reinstatement of LTBB Natural Resources privileges.
4. Privileges not be reinstated until the fine and costs due in this matter are paid in full.
5. Respondent must pay a filing fee of \$50.00 to petition the Court for reinstatement of privileges and licenses.







DEFAULT JUDGMENT

1. Default judgment is entered in the amount of \$ 100.00 (\$50.00 Fine and \$ 50.00 Court Costs) as stated on the Plea by Mail Form.
2. Return this notice with a certified check or money order in the amount of the judgment by February 26, 2004 by 5:00pm.

If you fail to pay, the Court will schedule a SHOW CAUSE HEARING for you to show cause why you should not be held in contempt of court for not paying the fine and court costs on time. If you are found to be in contempt of court, the court may REVOKE your LTBB Natural Resources privileges and you will be required to petition the Court for reinstatement of your LTBB Natural Resources privileges. Once privileges are revoked, they will not be reinstated until the fine and costs are paid in full AND you will be required to petition the Court for reinstatement of treaty privileges. You will also have to pay a filing fee of \$ 50.00 when you file the petition.
