UPON STIPULATION BY AND BETWEEN THE PARTIES and the Court  
being fully advised in the premises:

**IT IS HEREBY AGREED AND ORDERED** the Judgment renewed on August  
7, 2012 in the 90-2<sup>nd</sup> Judicial District Court in the amount of \$3,508.54 is hereby  
domesticated in the Little Traverse Bay Band of Odawa Indians Tribal Court;

**IT IS FURTHER AGREED AND ORDERED** that Plaintiff is to receive at least \$750.00 from the State of Michigan Income Tax Garnishment, in the event that the State sends the refund check to Defendant, the Defendant is to pay it over to Plaintiff;

**IT IS FURTHER AGREED AND ORDERED** that Defendant shall pay the Judgment in this case in installments of \$100.00 starting on June 20, 2013 and continuing on the 20<sup>th</sup> day of each month until paid in full or until further Order of the Court, so long as Defendant makes all payments as agreed Plaintiff will accept the total additional sum of \$2,250.00 as full satisfaction of this Judgment (inclusive of the monies received from the tax garnishment);

**IT IS FURTHER ARGEED AND ORDERED** that Defendant shall make all payments to P.O. Box 5996, Cleveland, OH 44101.




**IT IS FURTHER AGREED AND ORDERED** that no writ of garnishment on this Judgment shall issue until further Order of the Court;
