WHEREAS the Waganakising Odawak, known in English as Little Traverse Bay Bands of Odawa Indians is a nation of citizens with inherent sovereignty and right to self-governance and;

WHEREAS the Little Traverse Bay Bands of Odawa Indians ("LTBB") is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

WHEREAS the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected legislative body of the Tribe;

WHEREAS the Tribe wishes to ensure the future of the local transportation for the benefit of its members;

WHEREAS the Bureau of Indian Affairs, Indian Reservation Roads Program has provided the Tribe with an opportunity to indicate its updated Long Range Transportation Plan;

WHEREAS the Tribe wishes to ensure the future of the local transportation for the benefit of its members;

WHEREAS there are funds available through the Bureau of Indian Affairs for services that will meet those needs as identified by the Little Traverse Bay Bands of Odawa Indians.

THEREFORE, BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians approves the update to Appendix A of the Long Range Transportation Plan, approved in 2013.

FURTHER RESOLVED, that the LTBB Tribal Chair, Tribal Vice-Chair, Tribal Administrator, or another designee from the Tribal Chair is authorized to execute any documents necessary to apply for, receive, and administer related funds under the contract.
