RESOLUTION NUMBER 05029601

To approve the May 2, 1996 membership roll for the Little Traverse Bay Bands of Odawa Indians.

WHEREAS the Tribal Council of the Little Traverse Bay Bands of Odawa Indians (LTBB) as stated in the preamble to our constitution and bylaws is charged with among other things the perpetuation of our way of life, the preservation of our cultural heritage, and enhancing the health and welfare of our tribal members, AND

WHEREAS it is the Tribal Council's belief that the successful completion of the May 2, 1996 Membership Roll will enhance our tribe's ability to exercise our sovereignty and to provide for self-sufficiency, AND

WHEREAS language in Public Law 103-324, commonly called the Little Traverse Bay Bands of Odawa Indians and the Little River Band of Ottawa Indians Act, directs the tribal government to develop the May 2, 1996 Roll and to submit this roll to the Secretary of the Interior, AND

WHEREAS the LTBB tribal enrollment staff and enrollment committee acting pursuant to the LTBB Enrollment Statute (Waganakising Odawak Statute 1994-000) and the Interim LTBB Constitution and By-laws have researched and recommended approval of the membership roll.

NOW THEREFORE BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council hereby approves the May 2, 1996 Membership Roll consisting of 2251 tribal members,

AND BE IT FURTHER RESOLVED that the enrollment staff is directed to deliver this approved roll to the Bureau of Indian Affairs office in Sault Sainte Marie, Michigan before the close of business today.
