**RESOLUTION # 072102-02**  
**Submission of Corrected Membership Roll**

- WHEREAS** by Resolution 05029601 the Little Traverse Bay Bands of Odawa Indians submitted a roll of all members enrolled as of that date to the Bureau of Indians Affairs in accordance with Public Law 103-324 which totaled 2,251 members;
- WHEREAS** six LTBB members were eligible and enrolled as of May 2, 1996 but their names were inappropriately omitted from the list submitted.
- WHEREAS** five person's names were inappropriately included on the list whose enrollment applications were in fact denied on April 28, 1996 due to their enrollment in another federally recognized tribe;
- WHEREAS** nine people were inappropriately enrolled who were enrolled members in other federally recognized tribes and their membership was subsequently revoked;
- WHEREAS** the names of two persons who voluntarily relinquished their membership prior to May 2, 1996 were inappropriately included on the list.
- WHEREAS** the enrollment date of three members was amended to May 23, 1999 based on their eligibility under the Tribal Statute enacted on that date;

**THEREFORE BE IT RESOLVED** that the Little Traverse Bay Bands submits the attached corrected May 2, 1996 roll for publication in the Federal Register in accordance with Public Law 103-324. The roll contains 2,238 members after adding six and deleting nineteen based on the information above.

**Certification**

As Tribal Chairman and Tribal Secretary, we certify that this Resolution was duly adopted by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a regular meeting of the Tribal Council held on July 21, 2002 at which a quorum was present, by a vote of seven (7) in favor, zero (0) opposed, zero (0) abstentions, and zero (0) absent as recorded by this roll call.
