3. All Commissioners shall possess a properly issued and valid Little Traverse Bay Bands of Odawa Indians license issued for hunting, fishing and gathering; additionally, one of the Commissioners, if possible, shall also possess a valid Little Traverse Bay Bands of Odawa Indians license issued for commercial fishing and be an active commercial fisher.

**SECTION II. EFFECTIVE DATE**

Effective upon signature of the Executive or 30 days from Tribal Council approval whichever comes first or if the Executive vetoes the Statute, then upon Tribal Council override of the veto.


