**RESOLUTION 05199606**

**REQUEST FOR TRUST ACQUISITION**

**WHEREAS** the Secretary of the Interior is generally authorized to accept land into trust for the Little Traverse Bay Bands of Odawa Indians under the Indian Reorganization Act, 25 U.S.C. § 465, and is explicitly required to accept land into trust for the Little Traverse Bay Bands of Odawa Indians in Emmet and Charlevoix Counties, Michigan, by the Little Traverse Bay Bands of Odawa Indians and the Little River Band of Ottawa Indians Act, 25 U.S.C § 1300k-4 (a).

**WHEREAS** the Tribe has an interest in the following described parcel in Carp Lake Township, Emmet County, Michigan, which it desires to be held in trust for the Tribe by the Secretary of the Interior:

The Northeast quarter, excepting the Southwest quarter of the Northeast quarter, Section 11, Township 38 North, Range 4 West.

**WHEREAS** the Tribe intends to use this parcel for the development of housing in the vicinity of Mackinaw city, where there is a critical need for housing for tribal members. The parcel is located approximately four miles form the city limits of Mackinaw city, and a housing development at this site will be essential for the relocation of tribal members who will be employed in the various businesses scheduled for the Tribe's economic development venture on

the outskirts of Mackinaw City. Development is anticipated to include construction of housing, a community center and complementary open space to serve the needs of Tribal members.

**THEREFORE BE IT RESOLVED THAT** the Little Traverse Bay Bands of Odawa Indians requests that the Secretary of the Interior accept this parcel in trust for the Tribe.

**Certification**

As Tribal Chairman and Tribal Secretary, the undersigned certify that this Resolution was duly adopted by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a regular meeting of the Tribal Council held on May 19, 1996, at which a quorum was present, by a vote of 4 in favor, 0 opposed and 0 abstentions as recorded by this roll call.
