Approval of FY 2012 Tribal Transportation Improvement Program

WHEREAS the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians (“Tribe”), and its citizens are vested with inherent sovereignty and right to self-governance;

WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

WHEREAS the Little Traverse Bay Bands of Odawa Indians Tribal Council approved the 2006 Tribal Transportation Improvement Program in Resolution 030806-01; and,

WHEREAS under the Tribal Transportation Program, LTBB updates the Tribe’s Indian Reservation Road Inventory and the Long-Range Transportation Plan; and,

WHEREAS the Bureau of Indian Affairs funds the Tribal Transportation Program and requires updates at least every three years; and,

WHEREAS goals and priorities set in the 2010 Transportation Plan have been successfully met or have changed; and,

WHEREAS The Tribe wishes to ensure the future of the local transportation system for the benefit of its members,

THEREFORE, BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council approves the updated priorities and projects indicated in the FY 2012-2015 Tribal Transportation Plan;

BE IT FURTHER RESOLVED that the Tribe’s Chairperson is authorized to sign the documentation necessary to facilitate the Tribal Transportation Improvement Program.
