Assignment of Wycamp River Land Parcel,
4982 Chippewa Drive, Harbor Springs, MI 49740

WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe reaffirmed by the United States Congress on September 21, 1994 in Public Law 103-324, as amended, which exercises sovereign governmental authority over the people, land, and water within its jurisdiction;

WHEREAS the Little Traverse Bay Bands possess fishing, hunting, trapping, and gathering rights under the Treaty of Washington of March 28, 1836 (7 Stat. 491), and off-reservation hunting, fishing and gathering rights are executed through the 2007 Inland Consent Decree between the federal government, five tribal nations, and the State of Michigan entered by the Federal Court in *United States v. Michigan*, 2:73-CIV-26 (WD MI);

WHEREAS in September 2013, Little Traverse Bay Bands of Odawa Indians purchased land adjacent to Wycamp River, located at 4982 Chippewa Drive, Harbor Springs, MI 49740 (Tax ID 05-04-35-101-003) for \$ \$69,500;

WHEREAS Little Traverse Bay Bands of Odawa Indians purchased this property for river access for subsistence fishing and to monitor Wycamp Lake (Spirit Lake) for water quality;

WHEREAS in accordance with the Little Traverse Bay Bands of Odawa Indians Tribal Constitution, Tribal Council approves land uses, zoning and leases;

NOW THEREFORE BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby assign the land use the Wycamp parcel, located at 4982 Chippewa Drive, Harbor Springs, MI 49740 (Tax ID 05-04-35-101-003) to the Natural Resources Department to maintain and provide stewardship over the parcel.

BE IT FURTHER RESOLVED that this land use assignment shall remain in effect until such time that it is either revoked or revised by a majority vote of Tribal Council.
