Request for Funding from Enbridge Energy Partners,
Safe Community Grant
Protecting Tribal Properties: Oil Spill Response Supplies

WHEREAS the Waganakising Odawak, known in English as Little Traverse Bay Bands of Odawa Indians is a nation of citizens with inherent sovereignty and right to self-governance;

WHEREAS the Little Traverse Bay Bands of Odawa Indians ("LTBB") is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

WHEREAS the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected legislative body of the Tribe;

WHEREAS the Tribe's treaty delineated reservation area encompasses approximately 336 square miles in Northwestern-Lower Michigan;

WHEREAS the Little Traverse Bay Bands of Odawa Indians has a great concern regarding Great Lakes issues. The Tribe's concern stems from its duty to protect the environmental health and safety of its members, and the Tribe's economic, cultural and subsistence treaty right to harvest Great Lakes fish;

WHEREAS the Enbridge Energy Partners Safe Community program provides funding for equipment acquisitions or training that help organizations better prepare to respond to environmental emergencies.

THEREFORE, BE IT RESOLVED that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians authorizes and supports this grant application Enbridge Energy Partners (EER) for purchase of oil spill response supplies.

FURTHER RESOLVED, that the LTBB Tribal Chair, Vice Chair, Direct Services Administrator, or another designee from the Tribal Chair is authorized to execute any documents necessary to apply for, receive, and administer funds under the grant.
