Assignment of Wilderness Land Parcel,  
27 East Wilderness Park Drive, Carp Lake Michigan

- WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe reaffirmed by the United States Congress on September 21, 1994 in Public Law 103-324, as amended, which exercises sovereign governmental authority over the people, land, and water within its jurisdiction;
- WHEREAS** in 2000, Little Traverse Bay Bands of Odawa Indians purchased land adjacent to Lake Michigan, located at 27 East Wilderness Park Drive, Carp Lake, Michigan 49718 (Tax ID 24-02-02-27-101-002) for \$ \$242,830;
- WHEREAS** the land was placed into trust with the Secretary of Interior in October of 2001;
- WHEREAS** the Wilderness land parcel contains three small cabins that can be rented out for economic development purposes. The Executive Office has been assigned the land use and management of the cabins;
- WHEREAS** the Natural Resources Commission, Environmental Services would like to store a trailer with equipment for potential oil spills in the Straits of Mackinaw on the Wilderness land parcel;
- WHEREAS** in accordance with the Little Traverse Bay Bands of Odawa Indians Tribal Constitution, Tribal Council approves land uses, zoning and leases;

**NOW THEREFORE BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby continue the land assignment and management of the Wilderness cabins to the Executive Office for economic purposes and assigns a portion of the Wilderness parcel, located at 27 East Wilderness Park Drive, Carp Lake, Michigan 49718 (Tax ID 24-02-02-27-101-002) to the Natural Resources Department, Environmental Services to store and maintain a trailer with equipment for possible oil spills in the Straits of Mackinaw.

**BE IT FURTHER RESOLVED** that this land use assignment shall remain in effect until such time that it is either revoked or revised by a majority vote of Tribal Council.


**CERTIFICATION**
