**WHEREAS** the Waganakising Odawak, known in English as Little Traverse Bay Bands of Odawa Indians is a nation of citizens with inherent sovereignty and right to self-governance and;

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians ("LTBB") is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected legislative body of the Tribe;

**WHEREAS** the Tribe wishes to ensure the future of the local transportation for the benefit of its members;

**WHEREAS** the Tribe recognizes information on roads within the Tribes Tribal Transportation Program Roads Inventory is dynamic and must be kept current to accurately depict the conditions of each road;

**WHEREAS** the Bureau of Indian Affairs, Indian Reservation Roads Program has provided the Tribe with an opportunity to update and manage the Tribe's Tribal Transportation Program Roads Inventory via an on-line database management system;

**THEREFORE, BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians gives authority to the LTBB Planning Department to manage and update the LTBB roads inventory via the on-line database management system from January 01, 2017 through December 31, 2017.

**FURTHER RESOLVED**, that the LTBB Tribal Chair, Tribal Vice Chair, Direct Services Administrator, or another designee from the Tribal Chair is authorized to execute any documents necessary to apply for, receive, and administer related funds related to the roads inventory.
