Bureau of Indian Affairs Indian Reservation Roads Inventory  
9-mile point removal

**WHEREAS** the Waganakising Odawak, known in English as Little Traverse Bay Bands of Odawa Indians is a nation of citizens with inherent sovereignty and right to self-governance;

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians ("LTBB") is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected Legislative body of the Tribe; and

**WHEREAS:** the Little Traverse Bay Bands of Odawa Indians built 9- mile point access to exercise treaty rights for fishing and gathering; and

**WHEREAS** the Tribe utilized BIA roads funds for the engineering of 9-mile Point access route # 1067; and

**WHEREAS** the Tribe wishes to remove 9-mile point access route # 1067 from the Reservation Roads Inventory; and

**THEREFORE, BE IT RESOLVED** that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians authorizes and supports this request to remove 9-mile point access route # 1067 from the LTBB Indian Roads Inventory and return the \$50,000.00 that was utilized for engineering.

**FURTHER RESOLVED**, that the LTBB Tribal Chair, Vice Chair, Direct Services Administrator, or another designee from the Tribal Chair is authorized to execute any documents necessary to apply for, receive, and administer funds under the grant.
