Reversion of Land Use of Bells

229 S. Huron Road, Mackinaw City, Michigan

**WHEREAS** the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

**WHEREAS** on September 3, 2015, at a Regularly Scheduled Tribal Council meeting, Tribal Council passed a motion to designate and assign the property, structure, assets and equipment at 229 South Huron Avenue, Mackinaw City, Michigan to the Executive and authorize the Executive oversight of Bell's Fishery, the business located at the property, upon the dissolution of the Odawa Fishery, Inc.;

**WHEREAS** at the end of December 2016, the business of Bell's Fishery closed and there has not been any plans presented for the reopening of Bell's Fishery;

**WHEREAS** the property (Bell's Fishery) is no longer being used by the Executive for the designated land use purpose;

**WHEREAS** in accordance with the Little Traverse Bay Bands of Odawa Indians Tribal Constitution, Tribal Council approves land uses, zoning and leases.


**NOW THEREFORE BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby acknowledge the reversion of the assigned property of Bell's

Fishery, located at 229 S. Huron Road, Mackinaw City, Michigan from the Executive and the property hereby reverts back to Tribal Council.


**CERTIFICATION**


