Request to Accept Funding from the U.S. Department of Health and Human Services
FY 2018 Family Violence Prevention and Services Program, Mod-01 Funding Increase

- WHEREAS** the Waganakising Odawak Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and right to self-governance;
- WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);
- WHEREAS** the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected Legislative body of the Tribe;
- WHEREAS** the Tribe operates a Human Services Department with the primary mission to support and preserve all aspects of family life and to wrap LTBB Human Services around the Tribal community;
- WHEREAS** the Tribe recognizes the need to prevent incidents of and improve the services available to victims of family violence, domestic violence, and dating violence and their dependents;
- WHEREAS** the Tribe was awarded a United States Department of Health and Human Services, Administration for Children and Families FY 2018 Family Violence Prevention and Services Program grant to assist in efforts to increase public awareness about, and primary and secondary prevention of, family violence, domestic violence and dating violence, and to provide immediate shelter and supportive services for victims and their dependents.
- WHEREAS** the project funds have been increased by \$16,484 from the \$29,896 initial allotment to \$46,380 in allotted funds for FY 2018.



THEREFORE BE IT RESOLVED that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians supports and authorizes acceptance of additional funds in the amount of \$16,484 from the United States Department of Health and Human Services, Administration for Children and Families for the FY 2018 Family Violence Prevention and Services Program.

FURTHER RESOLVED, that the LTBB Tribal Chair, Vice Chair, Direct Services Administrator, or another designee from the Tribal Chair is authorized to execute any documents necessary to apply for, receive, and administer funds under the grant.
