Designation and Assignment of Wah-Be-Noong (Heynig Road) Land Parcel,
Harbor Springs, Michigan

WHEREAS the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe reaffirmed by the United States Congress on September 21, 1994 in Public Law 103-324, as amended, which exercises sovereign governmental authority over the people, land, and water within its jurisdiction;

WHEREAS in 1999, Little Traverse Bay Bands of Odawa Indians purchased vacant land on Heynig Road, Township of West Traverse, County of Emmet, State of Michigan, described as follows:

The East 1/2 of the Northwest 1/4 of Section 36, Township 36 North, Range 6 West, Michigan Meridian, containing 80 acres more or less.

WHEREAS since the purchase date in 1999, there are still nineteen (19) vacant lots on the Wah-Be-Noong (Heynig Road) parcel;

WHEREAS it is intent of the Tribe to utilize the remaining vacant lots for housing development;

WHEREAS in accordance with the Little Traverse Bay Bands of Odawa Indians Tribal Constitution, Tribal Council approves land uses, zoning and leases.

NOW THEREFORE BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby designate Wah-Be-Noong (Heynig Road) parcel for housing development.

BE IT FURTHER RESOLVED that Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby assign the Wah-Be-Noong (Heynig Road) nineteen (19) vacant parcels to the Odawa Economic Affairs Holding Corporation doing business as (d/b/a) Odawa Property Managers.

BE IT FURTHER RESOLVED that the Odawa Economic Affairs Holding Corporation doing business as (d/b/a) Odawa Property Managers will work closely with the Executive in alignment with the needs of the LTBB Housing Department in developing the Wah-Be-Noong (Heynig Road) parcel.

FINALLY, BE IT RESOLVED that this is a temporary designation, and shall continue until such time that the designation is either revoked or revised by a majority vote of Tribal Council.


