Assignment of Cemetery Road Property,
Petoskey, Michigan

WHEREAS the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe reaffirmed by the United States Congress on September 21, 1994 in Public Law 103-324, as amended, which exercises sovereign governmental authority over the people, land, and water within its jurisdiction;

WHEREAS in 2017, Little Traverse Bay Bands of Odawa Indians purchased vacant land on Cemetery Road in Petoskey, describe as “The East 1/2 of the Southwest 1/4 of the Northeast 1/4 and the South 34 rods of the Southeast 1/4 of the Northeast 1/4 of Section 12, Township 34 North, Range 6 West” (Tax ID # 13-18-12-200-015;

WHEREAS the Cemetery Road parcel is vacant and was used for crop planting prior to the purchase by the Tribe;

WHEREAS the Executive would like to utilize the property for the planning of crops and has submitted site plan for the Cemetery Road Property;

WHEREAS the Executive would like to utilize the property for the hunting, with the hunting season beginning on November 1st through Sunday of the first full weekend in January;

WHEREAS in accordance with the Little Traverse Bay Bands of Odawa Indians Tribal Constitution, Tribal Council approves land uses, zoning and leases;

NOW THEREFORE BE IT RESOLVED that the Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby designate Cemetery Road property, Petoskey, Michigan for crop planting; and designate Cemetery Road property for hunting beginning on November 1st through Sunday of the first full weekend in January, as depicted by the Site Plan dated February 11, 2019.

BE IT FURTHER RESOLVED that this is a temporary designation, and shall continue until such time that the designation is either revoked or revised by a majority vote of Tribal Council.

CERTIFICATION

As the Tribal Council Legislative Leader and Tribal Council Secretary, certifies that this Certified Motion was duly approved by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a regular meeting of the Tribal Council held December 19, 2019 at which a quorum was present, by a vote of 8 in favor, 0 opposed, 0 abstentions, 1 absent as recorded by this certification as an official action on behalf of Little Traverse Bay Bands of Odawa Indians.
