Request for Funding from Michigan Department of Health and Human Services,
Tribal Coronavirus Disease 19 Response FY 2020

WHEREAS the Waganakising Odawak, known in English as Little Traverse Bay Bands of Odawa Indians is a nation of citizens with inherent sovereignty and right to self-governance;

WHEREAS the Little Traverse Bay Bands of Odawa Indians (“LTBB”) is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States the most recent of which being the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621);

WHEREAS the Little Traverse Bay Bands of Odawa Indians Tribal Council is the elected Legislative body of the Tribe;

WHEREAS LTBB has issued a Statement of Emergency (attached) in relation to the COVID-19 pandemic.

WHEREAS LTBB has implemented several emergency preventative measures to reduce the risk of exposure to staff and to our health clients;

WHEREAS promotion of the health and welfare of the tribal community is a priority of the Little Traverse Bay Bands of Odawa Indians; and

WHEREAS the Michigan Department of Health and Human Services (MDHHS) has announced availability funding to strengthen tribes’ capabilities to prevent or reduce morbidity and mortality from public health incidents whose scale, rapid onset, or unpredictability stressed the public health and healthcare systems.

THEREFORE, BE IT RESOLVED that the Tribal Council of the Little Traverse Bay Bands of Odawa Indians authorizes and supports this grant application to the Michigan Department of Health and Human Services for a 7-month Coronavirus response project.
