Designation and Assignment of a portion of 7500 Odawa Circle, Harbor Springs,  
Michigan Land Parcel, SW Funeral Home Area

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians (LTBB) is a federally recognized Indian Tribe reaffirmed by the United States Congress on September 21, 1994 in Public Law 103-324, as amended, which exercises sovereign governmental authority over the people, land, and water within its jurisdiction;

**WHEREAS** in 2000, Little Traverse Bay Bands of Odawa Indians purchased vacant land in the Township of Little Traverse, County of Emmet, State of Michigan, Michigan containing 97 acres, more or less:

The East 1,650 feet of the Southeast 1/4 of Section 9, Township 35 North, Range 5 West EXCEPTING THEREFROM the east 50 feet of the Southeast 1/4 of Section 9, Township 35 North, Range 5 West.

**WHEREAS** it is intent of the Tribe to utilize a portion of the property for economic development purposes;

**WHEREAS** the Tribal Burial Board would like to utilize a portion of 7500 Odawa Circle, Harbor Springs, Michigan for economic development purposes;

**WHEREAS** there is vacant land on the southwest portion of the property that is suitable for a funeral home and other finance economic opportunities that are in conjunction or ancillary to burials, as identified in the Funeral Home Draft Project map dated June 5, 2020, as noted as the "SW Funeral Home Area";

**WHEREAS** the Tribal Burial Board will submit a site plan at a later date for Tribal Council's approval;

**WHEREAS** in accordance with the Little Traverse Bay Bands of Odawa Indians Tribal Constitution, Tribal Council approves land uses, zoning and leases;

**NOW THEREFORE BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby designate the "SW Funeral Home Area" as identified on the Funeral Home Draft Project map of 7500 Odawa Circle, Harbor Springs, Michigan dated June 5, 2020 for economic development purposes;


**BE IT FURTHER RESOLVED** that Little Traverse Bay Bands of Odawa Indians Tribal Council does hereby assign the "SW Funeral Home Area" as identified on the Funeral Home Draft Project map of 7500 Odawa Circle, Harbor Springs, Michigan Land Parcel dated June 5, 2020 to the Tribal Burial Board.

**FINALLY BE IT RESOLVED** that this is a temporary designation and assignment, and shall continue until such time that either the designation or assignment is either revoked or revised by a majority vote of Tribal Council.
