**RESOLUTION 08079701  
USDA FOOD COMMODITY PROGRAM**

**WHEREAS** the Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe, as reaffirmed by Public Law 103-324, as amended, and is eligible and qualified to apply for contracts/grants with the U.S. Department of Agriculture to plan, conduct and administer the Food Distribution Program;

**WHEREAS** the Tribal Council has determined that it desires to exercise the contracting/granting option;

**THEREFORE BE IT RESOLVED THAT:**

1. the Tribal Council has reviewed the proposed grant/contract and approves said proposal, under which the Bay Mills Indian Community will order and store the food to be distributed by the Little Traverse Bay Bands of Odawa Indians; and
2. the Tribal Chairman or his designee is authorized to sign the original contract/grant document, any budget modifications, and submissions of financial documents thereafter.

**Certification**

As Tribal Secretary, the undersigned certifies that this Resolution was duly adopted by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a special meeting of the Tribal Council called for this purpose held on August 7, 1997 at which a quorum was present, by a vote of 6 in favor, 0 opposed and 0 abstentions as recorded by this roll call.
