RESOLUTION 10119802

REQUEST FOR TRUST ACQUISITION

WHEREAS the Secretary of the Interior is generally authorized to accept land into trust for the Little Traverse Bay Bands of Odawa Indians under the Indian Reorganization Act, 25 U.S.C. § 465, and is explicitly required to accept land into trust for the Little Traverse Bay Bands of Odawa Indians in Emmet and Charlevoix Counties, Michigan, by the Little Traverse Bay Bands of Odawa Indians and the Little River Band of Ottawa Indians Act, 25 U.S.C § 1300k-4 (a).

WHEREAS the Tribe has an interest in the following described parcel in Bear Creek Township, Emmet County, Michigan which it desires to be held in trust for the Tribe by the Secretary of the Interior:

Commencing at the South 1/4 of Section 7, Township 34 North, Range 5 West thence North 01°02'30" East 133.03 feet to a T-iron stake which is the Point of Beginning; thence West 425.07 feet to a T-iron stake; thence North 05°08'30" East 120.16 feet to a T-iron stake; thence North 03°06'30" East 408.43 feet to a T-iron stake; thence South 89°54'30" East 401.67 feet to a T-iron stake; thence South 01°02'30" West 526.91 feet to the Point of Beginning; being a part of the Southeast 1/4 of the Southwest 1/4 of said Section 7.

WHEREAS the Tribe intends to use this parcel as an economic development site to help generate the revenue necessary to promote further economic development, self-sufficiency and a

strong tribal government capable of providing its members with needed services, including housing, health programs, cultural and educational programs and other vital governmental services.

THEREFORE BE IT RESOLVED THAT the Little Traverse Bay Bands of Odawa Indians requests that the Secretary of the Interior accept this parcel in trust for the Tribe.
