**RESOLUTION # 031900-04
INTER-GOVERNMENTAL LAW ENFORCEMENT**

WHEREAS the Little Traverse Bay Bands of Odawa Indians is currently engaged in negotiations with the Michigan State Police and local units of government to develop inter-governmental agreements to address law enforcement issues involving LTBB's trust land;

WHEREAS interim measures are needed immediately to protect the public safety both within and outside of LTBB's trust land;

THEREFORE IT IS RESOLVED THAT pending the completion and approval of written agreements between LTBB, the Michigan State Police and local units of government, the Tribal Council approves the following protocol:

1. **Non-emergencies:** In non-emergency situations, a law enforcement officer of the State of Michigan or local unit of government may only enter onto LTBB's trust land after first contacting and receiving permission from LTBB's Police Department to do so. LTBB's Police Department may approve or deny such request in its discretion, and may condition approval of such request on an LTBB officer accompanying the non-Tribal officer onto the trust land.

2. **Life Threatening Emergencies:** In life threatening emergency situations on LTBB's trust land, the nearest car of any governmental unit may respond, and the LTBB Police Department shall be notified as soon as possible.

Certification

As Tribal Chairman and Tribal Secretary, the undersigned certify that this Resolution was duly adopted by the Tribal Council of the Little Traverse Bay Bands of Odawa Indians at a regular meeting of the Tribal Council held on March 19, 2000 at which a quorum was present, by a vote of 7 in favor, 0 opposed and 0 abstentions as recorded by this roll call.
