RESOLUTION # 071303-02
Request for Trust Acquisition

WHEREAS the Secretary of the Interior is generally authorized to accept land into trust for the Little Traverse Bay Bands of Odawa Indians ("LTBB" or "Tribe") under the Indian Reorganization Act, 25 U.S.C. § 465, and specifically mandated to accept transfer of lands in trust for LTBB within Emmet and Charlevoix Counties, Michigan under 25 U.S.C. § 1300k-4(a);

WHEREAS the Little Traverse Bay Bands of Odawa Indians possesses clear title in fee to the property located at 911 Spring Street, Petoskey, MI, more particularly described as follows, which it intends to transfer to the United States in trust for the Tribe:

Situated in the City of Petoskey, Emmet County, Michigan: Commencing at the SW Cor. Of Sec. 6 T34N, R5W; thence N89°09'50"E 1144.20 feet to the West 1/8 Cor. of the South line of said Sec. 6; thence N00°11'50"E 1341.46 feet along the West 1/8 line of said Sec. 6; thence N11°50'40"E 45.76 feet to the P.O.B. ; thence N00°11'50"E 138.00 feet along the Easterly R.O.W. line of US 131; thence N88°50'40"E 313.46 feet; thence S00°10'50"W 138.00 feet to the Northerly R.O.W. line of Morgan St.; thence S88°50'40"W 313.50 feet along said R.O.W. line to the P.O.B.; being a part of the NE 1/4 of the SW 1/4 of said Sec. 6.




Certification
