**TRIBAL RESOLUTION #092817-02**

Use of 3<sup>rd</sup> Party Support Revenues for Tribal Pharmacy in the Amount of \$292,000.00

**WHEREAS** The Waganakising Odawa Nation, known as the Little Traverse Bay Bands of Odawa Indians, and its citizens are vested with inherent sovereignty and rights of self-governance; and

**WHEREAS** The Little Traverse Bay Bands of Odawa Indians is a federally recognized Indian Tribe under Public Law 103-324, and is a party to numerous Treaties with the United States, the most recent of which are the Treaty of Washington of March 28, 1836 (7 Stat. 491) and the Treaty of Detroit of 1855 (11 Stat. 621); and

**WHEREAS** The Little Traverse Bay Bands of Odawa Indians is governed by a Tribal Constitution adopted by the citizens of the Tribe on February 1, 2005; and

**WHEREAS** More funding is needed to hire another Pharmacist and tech for Prescription services ; and

**WHEREAS** In accordance with the WOS 2015-016 Tribal Government Budget Formulation and Modification Statute;

**THEREFORE BE IT RESOLVED** that the Little Traverse Bay Bands of Odawa Indians Tribal Council authorizes and approves use of in the amount of \$292,000.00 for the purpose additional staff for the Pharmacy 2017 with funding to come 3<sup>rd</sup> Party Support Revenues.


