THE COURT FINDS:

DEFAULT JUDGMENT FOLLOWING SHOW CAUSE HEARING

A Show Cause Hearing was scheduled in this matter on July 7, 2006, for Richard A. Boda's failure to file his March 2006 catch report as required by the Chippewa Ottawa Resource Authority (CORA). The Honorable Jenny Lee Kronk, Little Traverse Bay Bands (LTBB) of Odawa Indians Associate Judge, and Kevin Willis, Director of LTBB's Natural Resources Department, were present at the hearing. Mr. Boda failed to appear at the hearing; notice was sent to his last known address. The notice advised Mr. Boda that a default judgment would be entered if he failed to appear.

Findings of Fact

Director Willis testified that Mr. Boda failed to file his CORA March 2006 catch report that was due on April 10, 2006, a violation of Section XXII "Harvest Reporting and Sampling," Subsection (a), of the Commercial Subsistence and Recreational Fishing Regulations.

Conclusions of Law

The Court finds that Mr. Boda violated Section XXII "Harvest Reporting and Sampling" Subsection (a) of the Commercial Subsistence and Recreational Fishing Regulations by failing to file his March catch report by April 10, 2006, and has failed to show cause of why judgment should not be entered against him.

Therefore, IT IS ORDERED that **Richard A. Boda's fishing privileges are suspended until he files the March 2006 CORA report and pays a fine of \$50.00 and court costs of \$50.00.**
